RENTAL AGREEMENT

DUE TO FLUCTUATING FUEL PRICES: We are temporarily applying a fuel surcharge to the container cost

C&D CONTAINERS PROHIBITED ITEMS:

GENERAL CONSTRUCTION AND DEMOLITION

- **NO** FOOD WASTE OR HOUSEHOLD TRASH
- **NO** Hazardous Waste, Household Chemicals, Fuel, Wet Paint
- **NO** excess of (25% or more) pressure treated wood
- **NO** railroad ties or landscape timbers
- **NO** masonry, concrete or yard waste

HOUSEHOLD CLEAN-OUT PROHIBITED ITEMS:

GENERAL HOUSEHOLD ITEMS

- **NO** Hazardous Waste, Chemicals, Fuel, Wet Paint

SPECIALTY CONTAINERS: (SPECIAL REQUEST)

YARD WASTE ONLY | CONCRETE WASTE ONLY

ASPHALT PAVEMENT ONLY | MASONRY WASTE ONLY

BLOCKED CONTAINERS, MOVING OR DELAYS

GO-BACK FEE: \$100-\$150

- If the container is NOT accessible (blocked)
- If we are at the site strictly to move the container on the property without emptying.
- If Delivery/Removal/Swap is requested but the customer is not ready when we arrive and asks us to come back on a different day or time

DIFFICULT TO MANAGE LOADS:

A load may be labeled "Difficult to Manage" (DTM) and the customer will be responsible for any surcharge at an additional **\$60/TON**

OVERLOADED CONTAINERS:

Will not be hauled and the customer will be required to unload container to a level that is safe to haul.

• 4YD/6YD/8YD:

- Must be able to fully close the flip-top lids

• 15YD/20YD/30YD:

- Do not fill above the top of the container (nothing protruding higher).

ALL SIZES: Anything on the ground will not be taken

OVERLOADED FEE: \$100

(if above top but driver can still pick up the load)

GO-BACK FEE: \$150

(if pickup needs to be rescheduled)

AFTER 7 DAYS: CONTAINER RENTAL FEE

4YD/6YD/8YD: **\$10/DAY**; 15YD/20YD/30YD: **\$5/DAY**

EXTRA FEES:

Fees are subject to change, based on disposal site rates.

\$20 EACH:

- Carpets (Larger than 4'x6')
- Small Appliances
- Small TVs or Monitors

\$40 EACH:

- Large Appliances
- Large TVs or Monitors

\$50 EACH:

- Tires

\$65 EACH:

- Mattresses
- Box Springs
- Sleeper Sofa

PLACEMENT: PLEASE PROVIDE SPECIFIC PLACEMENT INSTRUCTIONS ON THE PROPERTY.

Dumpsters can be heavy enough to impact the surface they are placed on. If you are concerned, we suggest placing something down for support to the surface like wood blocks or plywood to place the container on and protect the surface.

BY THE CUSTOMER!**

**PAYMENT REQUIRED ON THE DAY OF REMOVAL OR SWAP
THE FULL RENTAL FEE WILL BE CHARGED TO YOUR CARD ON FILE**

ANY ADDITIONAL OVERAGE FEES, SPECIALTY DISPOSAL FEES OR RENT CAN TAKE UP TO 2 WEEKS TO BE INVOICED.
